For the benefit of our hobby, I ask each member to bring into our organization those folks who you know that are interested in insulators but don't already belong. These "closet collectors" benefit from our organization's work even though they are not members. We can help you and them better with funds generated from additional memberships. If you cannot sell them on membership, you might think of giving them a membership.

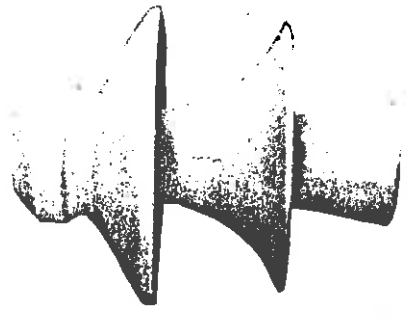

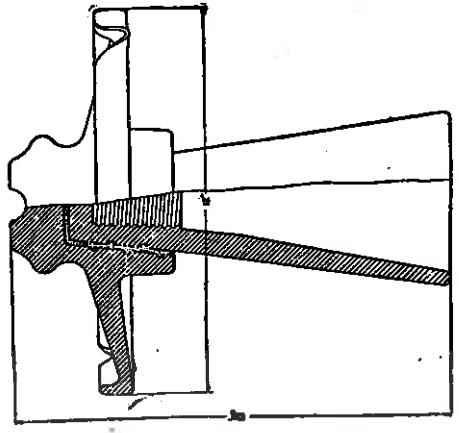
In a related matter, I note that only one local insulator club is currently a member of the NIA. I won't mention that club's name because of the embarrassment to the others, but I think it sad.

For those of you who remember the Sacramento National's California Insulator Display and the Herkimer Threadless Display, THIS is the scope we'll be dealing with! The display, which I've tentatively named "SELDOM SEEN", will be coordinated by MARILYN ALBERS and JEFF McCURTY. Anyone wishing to submit insulators for this display. The National will be held on Friday, July 11th (NIA members only) from 10:00 A.M. until 4:00 P.M. AT THIS TIME, it is anticipated that the NIA General Meeting will follow IMMEDIATELY after the show shuts down for the day (4:00 P.M.), next door at the Ramada Hotel. This will give everyone the chance to eat dinner afterward and mingle! It will also allow the possibility of an NIA Night at the Races, at the nearby Saratoga Harnes Track, which has an 8:15 post-time. More information on this will be upcoming. Also, there will be TWO SET-UP TIMES! On Thursday, July 10, there will be DISPLAY SET-UP and DEALER UNLOADING, from around 2:00 P.M. to 6:00 P.M. There will NOT be any DEALER MERCHANDISE allowed on the tables on

THURSDAY! This will keep things flowing quickly and allow the displayers time to set-up. On Friday, July 11, there will be normal set-up time, from 6:00 A.M. to 10:00 A.M. The general public show hours will be Saturday, July 12, and Sunday July 13, from 9:00 A.M. to 3:00 P.M. The public will be admitted FREE during these two days!

The NIA Board has approved the bid of Paul Ickes to host the 1986 Central Regional and it will be held in Omaha, Nebraska on May 10-11. Congratulations Paul! I urge all Central Region members to support this show. The Thirteenth General Meeting of the National Insulator Association was called to order by President Mike Bruner, who greeted the more than 50 members in attendance. Board members and committee chairmen were introduced.

The minutes of the Twelfth General Meeting, held at Tacoma, Washington, had been published in Drip Points, and Executive Director Kevin Lawless asked for and received approval unread.

The Treasurer, Rod Krupka, gave a report, and announced a balance of \$1253.96, as of June 6, 1985.

Eastern Region Vice President John deSouza reported on the upcoming Eastern Regional show, which Claude Wambold and Steve Bobb will hold in Kulpaville, PA.

In the absence of the Western Region Vice President, Second Past President Pat Patocka introduced Dee Willett and Mike Guthrie, who spoke on the Western Regional show in Bakersfield, CA.

Ethics Committee Chairman John McDougald reported on two incidents reported to him over the past year, which were settled without any further NIA involvement.

Historian Carol McDougald thanked those who made donations to the NIA Library. She also announced her resignation, due to her new commitments. Mike Bruner thanked Carol for her support and announced the new historian, Christopher Hedges.

Under old business, Marilyn Albers reported that at least 4 or 5 had contributed to Dawn Hole's family, who lost their home in Australia to fire last year. Dawn asked Marilyn to thank the NIA for its support.

Kevin Lawless announced the location of next year's shows:

The National (Eastern) will be held in Saratoga Springs, New York, on July 11-13, 1985, and show hosts are John deSouza, Kevin Lawless and Doug MacGilvary.

The Western Regional will be held in Enumclaw, Washington, on May 3-4 1986, and show hosts are Violet and Andy Brown.

The Central Regional will be announced at a later date. Nominations Chairman Mel Shootman announced the election of Dennis Weber as Central Region Vice President, replacing Mike Sovereign, who resigned.

Mike Bruner discussed the need to increase dues, with reasons given. The ratification process will begin after polling at this meeting and in Drip Points. The request will be for a dues increase to \$8.00 for regular and family memberships, effective March 31, 1986. Polling of the membership saw no objections to the increase. Bill Albers suggested the elimination of the additional vote for family members at \$1, but a poll of the membership rejected this motion. A lengthy discussion on the NIA's new computer ensued.

A request to change the NIA logo to something else, (i.e. CD162 or CD257) was discussed, with many mixed opinions. A poll of the membership in Drip Points will be taken.

Extra set-up time for displayers at Nationals was asked for by Tom Moulton. The NIA Board will look into this for future shows.

The Show Hosts, Mike Sovereign, Jim Crandall and Larry Veneziano were thanked for hosting the St. Charles National. The meeting was then adjourned.

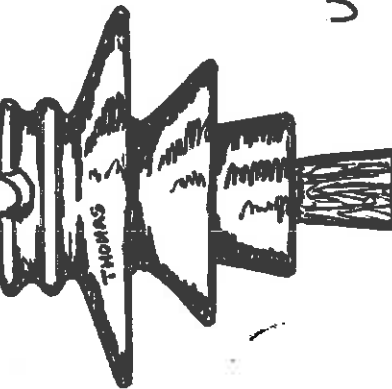


FROM THE CENTRAL REGION VICE PRESIDENT:

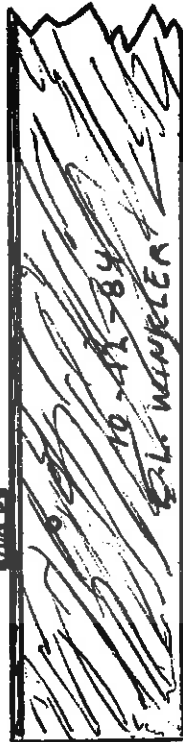

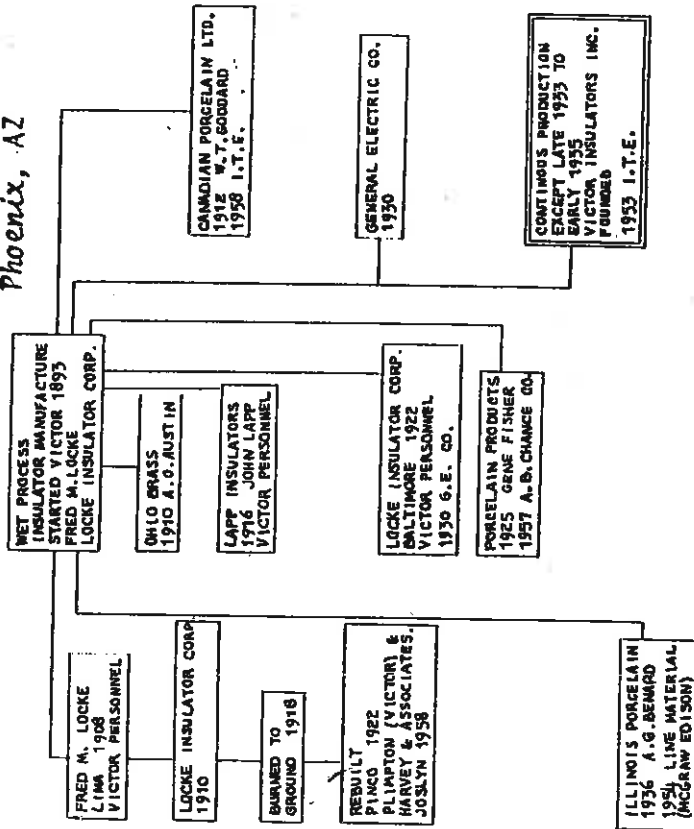
Ken:
