- The NIA membership year will change to: January 1 -December 31, effective January 1, 1993.
- By-laws change, Article II, Section 2.0. Change "six months" to read "three months". If you object to this change, please mail a written objection to me within 90 days. (Please refer to Article VII, Section 2.0 of your By-laws handbook)
- Deadlines for submissions to Drip Points have moved up one month. New deadlines for your articles are: July 20, October 20, January 20, and April 20.

I am pleased to announce that a new Committee Chairperson position has been activated. I have appointed Kevin Lawless to chair this new position entitled: Promotion and Education. Kevin will be concentrating on all avenues of promoting the hobby of insulator collecting. Thanks to a generous donation by member, Jim Bergman of Anchorage, AL, Kevin has an initial budget of \$1,000. to work with! I am hoping this important endeavor can be continually financed through a donation program supported by the membership. More details on this in the near future.

A new revised NIA Membership Handbook (revised 2/92) has been printed and is available upon request. Contact John deSousa for your copy.

FROM THE EASTERN REGION V-P

Running unopposed for another term as Eastern VP certainly made the campaign trail easier, but some competition would have been real welcome. Anyway, it appears I'll be in this post for another three years. I appreciate your confidence in me and hope that I can serve you in an expanded and proactive manner.

The Linscotts and Haymonds as well as a myriad of others I won't attempt to mention deserve a lot of credit for a well planned and orchestrated National show in Orlando this year. If there were glitches or things that fell through the cracks we never were aware of them. The facilities, albeit a bit on the pricey side were excellent for the show and the hall looked magnificent when we were admitted for set-up. There was a good array of merchandise for all. Thanks to some good publicity, particularly a gem of a feature article with photos in the Saturday morning Orlando paper, the walk-in on Saturday and Sunday was quite good. Many of us felt that the turnout on NIA day was on the light side and hopefully not a continued sign of light attendance at good shows that continues to vex our hobby.

The Middletown show in May which I was unable to attend was plagued by some inclement weather which may have contributed to less than hoped for attendance, but some good stuff changed hands. Claude Wambold's backyard show saw an absolutely beautiful day and those that attended had a great time and sold and traded well. Unfortunately, the attendance was very light in spite of a number of apparently serious inquiries (and subsequent no shows) from a larger number of people. Although not in the Eastern Region, I was a dealer at the Columbia City IN show in May. A good day, good publicity and a number of personal contacts by the show promoters stll failed to produce a good turnout. This enigma is really frustrating for the promoters, dealers and for the hobby itself. Seriously, the shows need the support of those within a reasonable distance. These are all good shows and will start to disappear without better support from our hobby.

Coming up we have the Sussex NJ show in August and the Capital District (Albany NY) in October. These are well worth attending. The Central Regional in London, OH deserves tha attention of EVERYBODY who is at all serious about the hobby. This show, which has been held for 20 some years has the promise of being a mini national in 1992.

Interesting finds are still out there. I've received letters from two fairly new collectors telling me of a CD 732 in blackglass they got for \$2 at an auction. Even with a few chips, that's not bad. Or--a Confederate egg picked up at an antique shop. There are rumors of a cobalt CD 724 floating around. Yours truly was able to pick up two nice Otises at a very reasonable price at a large antique market this spring. The same market yielded a beautiful blue CD 145 Pennycuick CHEAP. The latter had been on a table for nearly three days


when I found it on a rework of the field. A garage sale which yielded a two tone CD 162 amber Hemingray, a 162.1 Star and a bubbly CD 145 Pennycuick, all for \$9.00 has to be classed as a success. The stuff is still out there, so don't give up.

The NIA book donor program is really one of the finer things that can help get our hobby in the forefront where it belongs. Please consider making at least one donation to a library. Giving a short program to a school group, a historical society or another collectors group can be rewarding both to the hobby and to you. By giving the program you now have a chance to distribute literature on the NIA, Crown Jewels and the latest books and be the catalyst for a new collector. (this literature can be obtained from any NIA Board member, the McDougalds or can be reproduced from pages in Crown Jewels). It's a two edged sword also in that a supply of your cards or want lists made available to the attendees may well get you in on the ground floor of some great stuff.

Thursday, June 18, 1992

The meeting was called to order at 2:00 p.m. by President Eric Halpin. Present during the meeting were Marilyn Albers, Dwayne Anthony, Rick Baldwin, Dick Bowman, Eric Halpin, Ross Huth, Kevin Lawless, John McDougald, Don Reinke and Bernie Warren.

The President introduced Dwayne Anthony as the President Elect for the 1992-1993 term of office. Dwayne has been active in the Hobby for many years, he hosted the 1991 Western Regional Show and is currently serving as President of the Central/Southern Counties (CA) Insulator Club.

Board Members were asked to have their "Drip Point" articles to Don Reinke by July 20, October 20, January 20 and April 20 as production has been moved up a month. President Halpin also asked Board Members to help police NIA Day on Friday as all Show participants, including the public, must be NIA Members and wear an NIA badge.

A general discussion of the Outstanding Service and the Lifetime Membership awards took place with one Board Member questioning the need for the Lifetime Membership award. Consensus opinion of the Board was to redefine the purpose or meaning of the two awards but to continue using both awards as the Board saw fit. It was pointed out that the awards are not mandated each year but are given at the discretion of the Board.

The President initiated a discussion on the promotion of the Hobby through other advertising mediums, including the possible need for a Publicity Chairperson. Several standard articles on Insulator Collecting are now floating around that could be used for this purpose. It was noted that per Article III, Section 4.0 of the NIA By-Laws (page 3, NIA Membership Handbook), "The President may form committees and appoint chairpersons for such committees as required". The Board then made a point of giving their unanimous support to the President in pursuing this promotional activity.

The President and Ross Huth, Treasurer, reviewed the proposed 1992-1993 NIA budget with the Board. The \$1 coupon to "Crown Jewels" was discussed and will continue as is. The negative cash flow for the 91-92 year was duly noted with the new computer for the Membership Director and costs for publishing "Drip Points" mentioned as possible causes. It was noted that NIA promotional items had turned a cash profit during the past year in addition to having their inventory paid for.

Kevin Lawless then presented the pros and cons of changing the NIA membership year from the current April 1 to March 31 to a January 1 to December 31 calendar year effective January 1, 1993. Following a general discussion a motion was made, seconded and

approved by the Board "to change the NIA membership year from April 1 - March 31 to January 1 - December 31 effective January 1, 1993". It was noted that this Board action does not require General Membership approval.

A motion was then made, seconded and approved by the Board to change the last sentence of Article II, Section 2.0 of the NIA By-Laws (page 2, Membership Handbook) from "a membership renewal or new membership made within six months of the new membership year will be good for the following year", to read "a membership renewal or new membership made within three months of the new membership year will be good for the following year". This change will be presented to the Membership at the Friday General Membership Meeting for their approval.

Board conference calls were discussed briefly, as was Standard No. 18 (page 11, Membership Handbook) as it relates to the July 4 weekend reference for National Shows.

Dick Bowman encouraged Board Members to send a list of Board goals to the President who, in turn, would select the most important goals for each year. Dick would like to see the Board goals become more proactive and will write up his suggestions and send copies to Board Members.

Marilyn Albers spoke on the problem of no candidates volunteering to run for the NIA elective offices and the need for this situation to be clarified. It was pointed out that Dwayne Anthony was elected to a two-year term as President by acclamation as the only candidate and this action was supported by the Board. The President stated that the NIA By-Laws pertaining to elections will be enforced.

Bernie Warren shared information on the 1993 bids for the National and Regional Shows that were approved by the Board and will be announced at the General Membership Meeting on June 19.

The meeting was adjourned at 5:00 p.m. until July 1, 1993 in Denver, Colorado.

Twenty-Third National Insulator Convention Minutes of Business Meeting Airport Marriott Orlando, Florida

The Twentieth General Meeting of the National Insulator Association was called to order at 5:00 p.m. by President Eric Halpin, who greeted the more than sixty members in attendance.

Board Members and Committee Chairpersons present were introduced by the President, as were this year's National Show Hosts, Len and Jacque Linscott and Chuck and Sis Haymond. Dwayne Anthony, the newly elected President, was introduced and gave a short acceptance speech.

Old Business:

The Minutes of the Nineteenth General Meeting held in Cedar Rapids, Iowa and published in the October 1991 issue of "Drip Points" were approved.

The President shared highlights of the Board's actions during the 1991-92 year with the Membership. This included the purchase of a new computer for the Membership Director, the publishing of "Drip Points" by the Information Director and the Board's first ever conference call.

The Treasurer's report was presented and reviewed by Ross Huth. Year-end balance as of June 16, 1992 was \$6,128.17. It was also noted that thirty-six new members had joined the NIA during today's show.

New Business:

Board Members present gave brief accounts of activities in their areas. Marilyn Albers and Dick Bowman highlighted past and upcoming shows in their areas. Kevin Lawless, completing ten consecutive years on the NIA Board, stressed the need for new volunteers to assist the NIA. John McDougald shared information on the new NIA Membership Handbook, including by-law changes. Don Reinke discussed publication of "Drip Points" and urged the membership to contribute articles and information for publication.

Executive Director Bernie Warren announced the locations of the 1993 NIA shows:

The National Show and Convention will be held in Denver, Colorado on July 2-4, 1993. Don Reinke, Al Perry and Mike Bliss are the Co-Hosts.

The Eastern Regional Show will be held in Kulpsville, Pennsylvania on September 25-26, 1993. Stephen Bobb and Claude Wambold are the Co-Hosts.

A bid is currently in the works for the Central Regional Show.

Information on this show will be published in "Drip Points" as soon as the bid is received and approved by the Board.

President Halpin shared highlights of the June 18, 1992 Board meeting with the Membership.

- The Board's desire to become more proactive and promote the Hobby through a variety of advertising mediums. A new committee and chairperson may be needed.
- The creation of a new NIA membership year of January 1 to December 31, effective January 1, 1993.
- The Board's approval of, and recommendation to the membership, to change the last sentence of Article II, Section 2.0 of the NIA By-Laws (page 2, Membership Handbook) from "a membership renewal or new membership made within six months of the new membership year will be good for the following year" to "a membership renewal or new membership made within three months of the new membership year will be good for the following year".

It was moved that the above recommended by-law change be made. This motion was seconded and approved by the Membership, subject to confirmation by the Membership at large.

A discussion ensued regarding the current deadlines for submission of a national bid and the constraints a prospective Show Host faces in working with these deadlines.

A member questioned the expense involved for the smaller collectors in attending and participating in the National Shows. He suggested that public gymnasiums, fairgrounds and other sites should be considered. Former Show Hosts, Board Members and others contributed their thoughts on this subject.

A Member recommended that a hospitality room be provided the first evening for arriving collectors at a National Show.

The question of requiring NIA membership for a dealer to participate in the Friday NIA day was raised. It was clarified that membership was required for any dealer who sold primarily insulators.

The question of the Membership voting directly to select the best bid for the National and Regional Shows was raised. It was determined that this was properly a function of the NIA Board.

A Member complimented the NIA on their Library Book Donation Program, which is being administered by Mike Guthrie. Under this program, members may make gift donations of the McDougald's book "Insulators - A History and Guide to North American Glass Pintype Insulators" to their local libraries.

Carol McDougald, editor of "Crown Jewels of the Wire", announced that annual gift subscriptions of "Crown Jewels" would be provided to libraries for \$10 per gift subscription.

Don Reinke, a Co-Host for the 1993 Denver National, shared information with the Membership on next year's National Show and encouraged all to set their sights on Denver for 1993.

The meeting was adjourned at 6:30 p.m. until July 2, 1993 in Denver, Colorado.

FROM THE PROMOTION AND EDUCATION COMMITTEE

Thanks to the generous donation of our friend and fellow NIA member, Jim Bergman, of Anchorage, Alaska, the NIA has the opportunity to expand its horizons AND the boundaries of our hobby in general with the establishment of the NIA's Promotion and Education Committee. After ten years on the Board, I agreed to chair this committee for President Duane under one condition: that I DON'T have to attend the Board Meetings! Duane and I have established some preliminary guide-lines for our committee, which may include:

- 1. Establishing a blanket press release for use by ANY collector or club for the promotion of insulator collecting (not just a particular show or the NIA). This may, in fact, wind up being several versions of the same release, which could be used in newspapers; hobby and antiques press; electronics media; educational newsletters, such as railraod, telephone and utilities publications, or library releases; and as actual mass-produces brochures for handouts at libraries, museums, antique flea markets and the like.
- Making arrangements for distribution of Crown Jewels (three-year subscriptions, perhaps) to public libraries, similar to the Book Donor program aleady in place.
- 3. Coordination of public exhibitions and presentations. This is an area where our hobby is WOEFULLY short, both in effect and in experience. With proper coordination, we can successfully use the seed money contributed to the NIA to make major inroads into spreading the "Gospel according to Woodward-Tod-McDougald-Milholland-Albers, etc." and reach NEW collectors and, quite likely, OLD insulators which have never been seen before.

I am doing research into several areas already, but will be recruiting several new committee members who would like to take an ACTIVE part in the formation of this exciting and important new committee.
