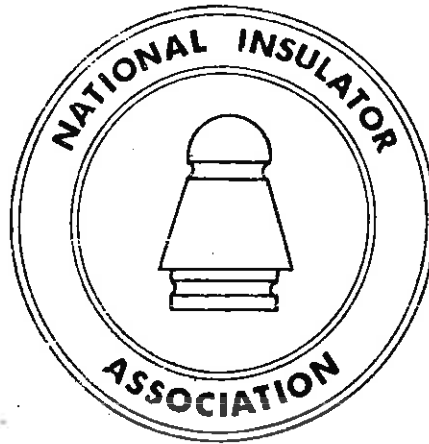

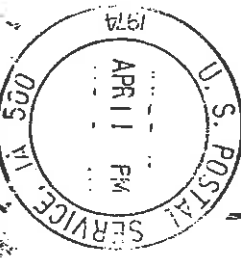

### DRIP POINTS

Hello,

I am Fred Griffin from Palatka, Florida. I am using this first National Insulator Association Newsletter for a short visit with you about our hobby and the NIA. As I visit with insulator collectors and dealers, I am usually asked three questions: Why do we need a national organization? What is its purpose? And what will the NIA do for me? These are good questions and here are some of my answers:

The hobby of insulator collecting has become nation wide -- yes, international in scope. Collectors from all parts of the United States and Canada should have an effective voice in the development of the hobby. There are many problems connected with most hobbies and insulator collecting has its share. These problems are concerned with ethics, standards, descriptions, judging and the exchange of insulators. Committees have been or are being established to study these problems and to recommend guidelines.

We are now preparing for the 5th National Show at Hershey, Pennsylvania (1st, Indianapolis; 2nd, Colorado Springs; 3rd, Kansas City; 4th Hutchinson). It is important that these shows be national in scope and that they are planned so they will be rotated among the three regions. As the hobby continues to grow regional and state shows will be, or continue to be developed.

We need a national organization to give visibility and prestige to our hobby. The insulator collector is no longer an orphan -- he now has an organization of his own.

The NIA has been in existence for less than six months. We have accomplished a number of important things during this short period of time. They include the adoption of by-laws, the election of officers, the appointment of committees, a suggested code of ethics, standards for national shows, the official emblem, the selection of the site for the Fifth National Show, and a membership of approximately 450.

I am proud to be your president and to have this opportunity to visit with you. I would like to ask you to do three things: 1) Invite your fellow collectors to join the

A note from Dennis McHenry on standards for a system for describing the embossing on an insulator. I learned this system from Bob Bowers, Manteca, CA and asked his permission to use it. I don't think he'd mind if it became the standard of the hobby. I'll quote his explanation and then use it. "Capitol letters indicate embossing, a / indicates another line same side, // indicates reverse side, D-dome, S-skirt, B-base. Abbreviations: SCA-Sun colored amethyst, SCAM-Sun Colored Amber, SDP or RDP-sharp or round drips, NIS-no inner skirt, MLOD-mold line over dome, BM-button mold, SB-smooth base." Now to describe an insulator which will use about everything talked about.

That's pretty complex, but accurate. It really tells you how the embossing looks and for those who collect embossing variations this is important. It even helps on simple embossing like:

- CD 145 HEMINGRAY//DOUBLE/PETTICOAT, aqua, SB
- CD 160 O.V.G.CO.//PETTICOAT PONY, aqua, SB

You can tell at a glance whether the reverse is on one line or two.

BY-LAWS  
NATIONAL INSULATOR ASSOCIATION

ARTICLE I -- PURPOSE

The National Insulator Association, herein noted as the NIA, shall be a non-profit educational and scientific organization to encourage insulator collecting and dealing, protect the interest of insulator collectors and dealers, and establish standards and ethics by which insulator collectors and dealers may fairly deal one with another.

ARTICLE II -- MEMBERSHIP AND DUES

All persons who are in any way interested in the insulator shall be eligible to apply for membership. The NIA Board of Directors shall set the dues for each class of member, subject to the approval of the membership, and may suspend or revoke a membership for just cause under Article VI.

The classes of membership in the NIA shall be Regular, Junior, and Family. Applicants under the age of 18 years are eligible for the Junior membership. The Family membership shall be open to the members of the immediate family of any adult holding a Regular membership and shall carry all the privileges of Regular or Junior membership except that of receiving the official organ or NIA mailings other than proxy ballots.

Any club of insulator collectors and/or dealers may apply for a Regular membership in the NIA upon payment of the annual dues. No such organization at the regional, district, state or local level shall become affiliated with the NIA until the organization has its by-laws approved by the NIA Board of Directors.

The NIA Board of Directors shall institute and maintain suitable procedures for reviewing and screening membership applications prior to final processing to minimize the necessity of later suspensions, revocations or expulsions.

ARTICLE III -- VOTING, HOLDING OFFICE, AND OFFICES

Each member, regardless of class, shall be entitled to vote at the annual meeting in appropriate elections and on all matters brought before the NIA.

All elected or appointed officers or representatives of the NIA shall be current Regular members.

The officers of the NIA shall be a President, three Regional Vice-Presidents (one of whom shall be designated as First Vice-President), Treasurer, Information Director, and Executive Director.

The President shall preside at all meetings of the NIA or the NIA Board of Directors and take such actions as will promote the purposes of the NIA. The President shall be elected by the members at the annual meeting, for a one-year term, to take office at the conclusion of that meeting.

The Regional Vice-Presidents shall be elected to staggered three-year terms at the annual meeting, and only the members residing in the specific region involved shall be eligible to vote for the single Regional Vice-President elected annually. Each Regional Vice-President shall take such action as will promote the purposes of the NIA in his region and nationally.

The First Vice-President shall annually be the most senior Regional Vice-President in rotation, and he shall preside over all NIA meetings in the absence of the President.

The Treasurer shall be appointed annually by the President and Regional Vice-Presidents and shall operate in a thorough and efficient manner to provide accurate records and handling of the finances of the NIA. He shall make disbursements of funds only as approved by the Board of Directors.

The Information Director shall be appointed annually by the President and Regional Vice-Presidents and shall coordinate communications, information, and publication services of the NIA, including the determination of the official publication.

The Executive Director shall be appointed annually by the President and Regional Vice-Presidents and shall serve as secretary and executive officer for the NIA. He shall take such actions as will promote the purposes of the NIA.

As future work load conditions might warrant, the Information Director or the Executive Director, or both, may be voted a fixed annual salary by the Board of Directors, subject to the approval of the membership.

#### ARTICLE IV -- GOVERNMENT AND MEETINGS

The Board of Directors shall be composed of the President, Regional Vice-Presidents, Treasurer, Information Director, Executive Director and the two most immediate past presidents. The Board shall meet at the call of the President and shall take such actions as will promote the purposes of the NIA. The quorum of the Board shall be five (5) Directors.

The three regions of the NIA shall be revised as necessary by the NIA Board of Directors. Members from the respective regions shall be eligible to vote for candidates for their respective Regional Vice-President. Each Regional Vice-President may develop organizations within his region or within districts, states, or local areas within the region, as will promote the purposes of the NIA.

The annual convention meeting of the NIA shall be held during the annual national insulator show in the specified region and shall be held at a time and place set by the Board of Directors. The 1974 annual meeting shall be held in the Eastern Region, in 1975 in the Western Region, in 1976 in the Central Region, and thereafter rotate in the same sequence. The quorum for any annual membership meeting of the NIA shall consist of those members present.

Official NIA-sponsored insulator shows shall be held annually in the two regions other than the one in which the annual meeting and show is held, and each of the other regional shows shall be identical in scope, as far as practical, with the annual meeting show except for the absence of an election and regular membership business meeting. The time and place of these regional shows shall be set by the NIA Board of Directors.

The NIA Board of Directors shall seek responsible members and NIA-affiliated organizations or clubs to serve as sponsors and hosts for all NIA-sponsored meetings and shows, and it shall be mandatory that all such NIA-sponsored shows are conducted in full agreement with the show rules formulated by the NIA Board of Directors.

#### ARTICLE V -- ELECTION

The NIA Board of Directors shall appoint a regionally representative nominating committee of three members which shall present nominations for the expiring offices at the annual meeting. The Board of Directors shall institute procedures for completion of these nominations in time to assure prior publication in the official publication and for inclusion on proxy ballots mailed to all members, but this shall not preclude the acceptance of floor nominations or written votes on ballots, proxy or otherwise. No nominees will be placed on the ballot, nor accepted as written votes, until they have advised the NIA of their willingness to serve.

The election shall be by written ballot. Members attending the meeting in person may retract their proxy ballot previously mailed if they have clearly identified the outside of the sealed mailing envelope containing the proxy envelope.

The NIA Board of Directors shall fill by appointment until the next annual meeting vacancies arising in any office. In the event a Regional Vice-President in a non-expiring term is elected to the office of President or is subsequently appointed to the office of Treasurer, Information Director, or Executive Director before the expiration of his Board term, his former position shall be treated as a vacancy of that office. In the event of a vacancy on the Board of Directors among the most immediate Past Presidents due to their resignation or to election or appointment in the Board through another office, the vacancy will be filled by appointment by the Board, the appointee serving out the remainder of that normal Board term.

ARTICLE VI -- STANDARDS AND ETHICS

The NIA Board of Directors shall adopt a code of ethics for insulator collectors and dealers and a set of standards for describing insulators to thereby promote fairness and uniformity in participation in the hobby.

The NIA Board of Directors, following due process of fact-finding and hearings, may suspend or revoke the membership or expel a member upon his failure to abide by and utilize the code of ethics or the standards for describing insulators.

ARTICLE VII -- AMENDMENTS

These by-laws may be amended by the membership at any annual meeting or through special mail ballot by an affirmative vote of two-thirds of all votes cast, providing a copy of the proposed change is made available to each member in advance, either directly by mail or by timely advance notice in the official publication.

ARTICLE VIII -- EFFECTIVE DATE AND IMPLEMENTATION

These by-laws shall become effective upon action and adoption by a majority of those present and voting at the meeting at the 4th National Show in Hutchinson, Kansas, called by the Organizational Committee established at the 3rd National Show.

Upon adoption, the Organizational Committee shall name a three-member nominating committee which shall present to the meeting nominees for President and for three Regional Vice-Presidents as prescribed in Article III.

In order to initiate the desired rotation of the First Vice-President always being the most senior of the three Regional Vice-Presidents and serving in that capacity during the year in which the annual meeting is held in his region, the initial 1973-74 Regional Vice-President terms are to be: East, 1-year term; West, 2-year term; Central 3-year term. The Eastern Regional Vice-President is the 1973-74 First Vice-President in line with this adopted rotation.

Reference Article IV, until such time as there are two separate past Presidents to complete the nine-man Board of Directors, the quorum of the Board shall consist of four Directors.

To immediately provide funds for operations, the Organizational Committee may set membership dues for 1973-74, collectable at the 4th National Show and at any other time during that fiscal year.

To provide for initial organization, the following regions are established, subject to review and change by the Board of Directors at any time:

Eastern: Alabama, Connecticut, Delaware, District of Columbia, Florida, Georgia, Maine, Maryland, Massachusetts, Mississippi, New Hampshire, New Jersey, New York, North Carolina, Pennsylvania, Rhode Island, South Carolina, Tennessee, Vermont, Virginia, West Virginia.

Central: Arkansas, Colorado, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Missouri, Nebraska, New Mexico, Ohio, Oklahoma, Texas, Wisconsin.

Western: Alaska, Arizona, California, Hawaii, Idaho, Montana, Nevada, North Dakota, Oregon, South Dakota, Utah, Washington, Wyoming.

CODE OF ETHICS

NIA members:

- (1) shall not engage in the manufacture, sale or exhibition of insulators or related items which can generally be termed frauds and which include, but are not limited to, deceptive reproductions or altered physical characteristics in any manner.
- (2) shall not engage in the manufacture of any reproductions, reprints, replicas, commemoratives or the like without first clearing the design with the NIA to make certain the items produced will not be termed "objectionable" to the hobby for any reason such as perpetration of fraud by secondary parties.
- (3) shall not engage in the sale, advertisement or exhibition of any insulators or related items deemed by the NIA to be "objectionable" in the best interests of the hobby.
- (4) shall make every effort to comply with standards established by the NIA for the accurate description of the type and condition of insulator specimens.
- (5) shall carry out trade and sale transactions expeditiously and fairly to the satisfaction of all parties involved.
- (6) conduct their collecting activities in a lawful manner and refrain from inferring to the public that the NIA or its members condone any harmful or unlawful practices in the pursuit of the hobby.
- (7) shall not knowingly misrepresent the rarity or value of insulators or related items they offer for sale or trade.
- (8) shall not make public accusations to fellow collectors about possible misconduct of any individual member or affiliated club, and shall refer such matters to the NIA office for arbitration.
- (9) shall not use any NIA emblems, insignia or credentials in any manner detrimental to the interests of the NIA and shall report to the NIA any such use by others.
- (10) shall abide by all rules and policies established by the NIA and not be a disturbing influence at any NIA meetings or insulator shows.

THE PRESIDENT'S REPORT

Hello Fellow Collectors,

Last summer insulator enthusiasts dreamed of a National Insulator Association that would serve them and the insulator hobby--to protect them when necessary; to represent them when needed--to serve the collector and further the insulator hobby. I am pleased to tell you that not only has our National Association been formed (Hutchinson, '73), but it is off the ground and going strong with over 600 members across the country and Canada. Quite an accomplishment for an organization only eight months old. Thanks for your support.

The NIA By-laws were formally adopted at Hutchinson by the members present. Your representatives that were elected at Hutchinson formed a committee to devise a Code of Ethics (see Newsletter #1) and Standards (see this Newsletter). Please bear in mind that the By-laws, Code of Ethics, and Standards are your committee's efforts to put what you want into writing. The committee welcomes and encourages criticism. We seek your ideas and suggestions in regard to anything the NIA does--because the NIA is really you, the collector, and its YOUR interests we are trying to serve. The by-laws are subject to amendment if you desire. The Code of Ethics and Standards are tentatively in effect. If you have suggestions for changes, revisions, omissions, or additions, please voice them so we can please you. Notify your Regional Vice-President or the Standards and Ethics Committee, or better yet, plan to be at Hershey and attend the business meeting on Saturday night and express your views in person.

NIA elections will also be held at Hershey for the office of President and Eastern Vice-President. I have asked Bill Dreggors, Executive Director, to be Chairman of a nominating committee consisting of the three Regional Vice-Presidents: Steve Freedman, Dick Augustyn, and Jesse Moreland. I will further ask each member to consider these posts, and to forward any nominations you may have on to your Regional VP. So, in effect, the entire NIA membership is really the nominating committee. This may also be the time to correct an old error. As you know, Jesse Moreland was elected Western Vice-President at Hutchinson by the membership in attendance. It wasn't until later that it was realized that Jesse is from Colorado, and Colorado is in the Central Region. The Board of Directors is mulling this problem now, and may recommend electing a new Western VP that would be from the Western Region. Certainly no adverse reflection on Jesse, we just need to straighten out this situation so the Western Region can be properly represented.

Consider carefully your nominations. Double check the by-laws. Note that a nominee must agree to having his name placed on the ballot, and must then accept the post if elected. It is important that all candidates be briefed as to duties ahead of time, so I am

asking all candidates to meet with the Board of Directors Thursday evening, June 27th, at Hershey if at all possible so they can be filled in on duties, etc., and potential new president can be forming a staff well before the business meeting on Saturday.

Nominations should be in by May 1, 1974, so that Ray will have time to prepare ballots and get these ballots back to you before the Hershey Show. This will give those members who can't attend the show an opportunity to mail their vote in.


